The Department of Defense Reserve Award Citation was presented to Scovill at a luncheon held recently. Not in the picture above but also seated at the head table were Lt. Comdr. W. B. Bockway, officer in charge of the Naval Reserve Training Center and Vice President Mark L. Sperry, Jr., a former Navy Lieutenant.

Representing Scovill reservists were: Grover C. Baldwin (Chief Quality Control Engineer) retired Air Force Reserve brigadier general; Anthony Brooks (Steam Dept.) Lieutenant, Naval Reserves, and Heinz O. Furtwangler, (Slide Fastener Sales) Major, Army Reserves.

The citation, signed by Charles Wilson, former Secy. of Defense, reads:—

"Scovill Manufacturing Company of Waterbury, Connecticut, is cited for outstanding cooperation with the Reserve Program of the Armed Forces. By its policies of granting military leave in addition to normal vacation periods, paying any difference between military and civilian pay, and discriminating in no way against reservists, the Company has encouraged employees to participate in Reserve activities. In addition, reservists are permitted to place news items in the Company newspaper. The support of the Reserve Program demonstrated by the Scovill Manufacturing Company is worthy of commendation and reflects great credit upon its management.

Mr. J. North Hathaway, Asst. Sales Manager, told of the switch-over to Hamilton Beach salesmen in selling our *GREEN SPOT* line and gave a brief overall picture of our distribution pattern across the country. Samples of advertising pieces and store display material were shown and given them.

Vice President Henry W. Wild spoke on production problems and told of the

importance of the contribution each person makes in the various departments toward turning out more and better products at a fair price.

Display in New York

In making the presentation, Mrs. Kunkle stated that, of a number of local employers considered by the committee for the citation, the Scovill main plant had demonstrated closest adherence to the principles involved in the hiring of the handicapped, namely: consideration of handicapped workers in hiring on the basis of matching remaining abilities with job requirement, proper induction, thorough training and careful follow-up on the job.

In accepting the citation, Mr. Curtiss expressed great pleasure and pride on behalf of the Company. He noted that, for some years, our practice has been to select workers on the basis of medical exams. Where applicants are found to have disabilities, the physical and mental requirements of the job are matched against the applicant's remaining abilities and, when found that the handicap will not prevent the worker from doing the job, he is hired. In this way, he reported, "we have obtained, over the years, some very valuable employees."

Did You Say "No"?

The majority of our Scovill employees, as good citizens, have always supported our local charities. That they have again done so in our 1957 United Fund Campaign is a matter of record.

Most Scovill employees are generous people. They know the agencies and the good work these agencies perform and they realize that their financial support is needed in order to continue that good work.

That's why they give-why they share-and we thank them for it.

The volunteers, both Union and Management representatives, who solicited their fellow workers, did a top-flight job. It is not easy to ask for money yet the response was most generous and we thank God for the good will of the many men and women who served as solicitors for they gave of themselves as well.

Now—what about our Scovill people who refused to sign their payroll deduction card and who were unwilling to contribute?

True, there were some who had a legitimate reason, but their numbers were few and far between.

The greater majority of these people refused because they were unwilling to share with their less fortunate neighbors. They were unwilling, some of them, to listen to reason and walked away from the solicitor; a very discourteous act on their part.

What happens when you say "No" to the United Fund?

Does it mean less money for the solicitor — the Union — Management? Of course not!

Does it mean less money for the United Fund staff — the agency executive? I don't think so.

Who then are you penalizing by refusing to donate?

You talk a lot about juvenile delinquency — yet by your refusal to donate, you expose your own youngsters as well as those of your neighbors by restricting the work of the Boys' Club, the Boy Scouts, the YMCA, the Girl Scouts, the Salvation Army, the Diocesan Bureau, Family Service, and the like.

You don't penalize the Fund — you don't penalize the agencies—you penalize the kids!

So you don't like this agency, or that agency. All right, but by withholding your support, you don't penalize that agency, you penalize your neighbor who depends on the agency. You may well penalize yourself for only God knows when you or I may need the services of one or more of the 35 agencies in the Fund.

So you said "No" to your solicitor. Do you still feel the same way? Don't penalize the needy and the unfortunate in our community, for that is what happens when you say "No" to United Funds.

There's still time to sign your payroll deduction card. See your solicitor now. You'll feel mighty good knowing that you too are giving.

Oils and Metals Do Double Duty

An enormous amount of oil is used in the Chucking and Automatic Screw Machine departments in the various operations of machining parts. Some metal also appears to be "lost" in the process. The oil and the metal chips are lost only temporarily, however.

Located in the first floor of Bldg. 109-1 is a department called "Oil Reclaiming." It is a small department but the operations performed there result in big savings in material and

This department receives the "used oil" from Chucking and Automatic Screw (located on the 4th and 5th floors) via chute. The oil is mixed with metal chips from machined parts.

The chips are cleaned of oil in a centrifuge then are processed through a magnetic machine where foreign steel parts are removed. The chips are weighed at the Shipping platform and sent, via truck, to the Casting Shop to be remelted for reuse.

The oil is also salvaged. As the chips are sent down the chute, some of the oil escapes and drains into a sump located under the chute. When the oil reaches a set level, it is piped automatically by pump into settling tanks where any possible water is separated from the oil. Oil which flows from the centrifuge also goes through these tanks. The oil is finally piped to the reservoir where it is kept for reuse. The only oil lost is by vaporiza-

The oil reclaiming (or extracting) operations performed in this department are for the use of the Chucking and Automatic Screw Machine departments located in the same building.


Our Salvage Dept. also has an oil reclaiming section which services almost all divisions of the main plant. We'll pick up this phase of oil reclaiming and salvaging next time.




Zenel Fazo shovels oily chips into basket as Belton Antrum holds open the lid of the door chute.
